FULL TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents who are Guardian Club members at the time of entry. Individuals who are not existing Guardian Club members can become members by visiting a participating Guardian pharmacy or visiting guardianpharmacies.com.au and following the prompts to join.
